#### □ What is the timeline for applications?

- Application forms for Kindergarten through 8th Grade will be available starting Monday, April 9, 2018 thru Friday April 27, 2018 at the Riley Education Center, 9601 Vine, between the hours of 7:30 a.m. and 4:00 p.m. Applications will also be available on our website www.allenparkschools.com. You must complete a separate application for each student.
- Completed application forms for Kindergarten through 8th Grade will be accepted from Monday April 9, 2018 through Friday, April 27, 2018. Completed applications may be presented in person at the Riley Education Center, 9601 Vine, between the hours 7:30 a.m. and 4:00 pm Monday through Friday. Completed applications may also be emailed to schoolofchoice@appublicschools.com
- Completed applications must be received on or before 4:00 p.m. Friday, April 27, 2018. No late applications can be accepted.
- NOTE: If any information is found to be inaccurate or false, the application will no longer be considered for acceptance.

#### □ Is there sibling preference?

By law, the siblings of Schools of Choice students (already attending APPS) have first priority if an opening exists. However, parents must complete the necessary application paperwork during the open application period.

## □ When will I know if my child has been accepted as a Schools of Choice student?

A random draw selection will take place on Tuesday, May 1, 2018 at 9:00 a.m. in the Riley Education Center Cafeteria. Public is welcome to attend. The draw will determine numerical selection for acceptance of candidates.

Within fifteen calendar days after the end of the application period, parents will be notified via phone call or email of whether the applicant was chosen or placed on the waitlist. Specific school placements of Schools of Choice students will be assigned after review of all school enrollment data. There will be a minimum of one opening per grade level K-8.

**Important Deadline:** If notified of acceptance in the Schools of Choice Program, applicants must complete enrollment paperwork within 8 calendar days of notification. If the enrollment is not completed within this timeframe the student's space will be forfeited.

**Wait List:** Those not selected will be placed on a wait list, and called in numerical selection order as positions become available.

- □ Is there an orientation for Schools of Choice families?
  - Please contact your student's individual school for student orientation dates and times.
- □ Will Schools of Choice guarantee my child's path through all subsequent levels in APPS?

Yes. After completion of any given level (i.e., elementary or middle) the student will advance to subsequent level as appropriate.

- ☐ If I am participating in APPS Schools of Choice and I move <u>within</u> Wayne County, can my child continue to attend APPS?
  - Yes. Please report any change of address within Wayne County to the Pupil Accounting Office at the Riley Education Center, 9601 Vine.
- ☐ If I am participating in APPS Schools of Choice and I move <u>out</u> of Wayne County, can my child continue to attend APPS?

No. At the end of the current semester, the student must register in his/her home residence district.

- □ Will my child receive transportation?
  - Transportation is <u>not provided</u> to Schools of Choice students and is the responsibility of the parent. Students are expected to arrive and depart from school on time.
